I, Colleen Palmer, parent of a 1st grade age TEC student, received an email with an offer that SPS would like to require "contact tracing" and "covid testing" for school. I would like to counter this offer regarding "contact tracing" and "covid testing":

<u>**Contact Tracing</u>** violates our privacy, Liberty, and autonomy, all of these must be secured and guaranteed prior to the implementation of this measure.</u>

<u>**Covid Testing**</u> violates our bodily integrity, and is not proven to be an effective or accurate test for the disease called "covid-19". A "positive test" is not proven to be a "case of disease", nor does it prove contagion. "Asymptomatic carriers", previously known as healthy people, are not proven to spread covid-19.

Covid testing, as a requirement for entering school, will become appropriate <u>only</u> <u>after:</u>

- 1. The SarsCOV-2 virus is isolated, and is
- 2. Proven (scientifically, repeatedly and independently peer reviewed) to be contagious in human to human contact, and
- 3. A test is created that can
 - a. identify with 100% accuracy a contagious illness in a human, and
 - b. that does not violate the privacy and bodily integrity of the person.

Implementing contact tracing and covid testing without meeting these requirements would be harmful to me and my family.

I would like to further alert you to the slippery slope toward technocratic tyranny that you, the school board and superintendents of school, are heading down. For yourselves and families, you are welcome to do whatever you feel makes you safe, but your decisions as a superintendent or board member will affect the men, women, and children of Spokane Public Schools. Since mandating these unproven and unnecessary measures would violate our inalienable rights, they will cause harm to all people and the community at large. **Liberty is inalienable, safety (either perceived or real) is not.** It is outside of your jurisdiction to mandate tests and tracing that would cause harm to others.

School is for learning, not medical intervention.

School is traditionally a place of learning, not of medical care, and these two areas of life must not be mixed. Never before have healthy people been required to undergo an invasive medical test in order to go about their normal lives, which includes going to school or to work. Health care is a protected and private matter governed by the parent or adult. It is inappropriate for any invasive medical testing to take place on school grounds or be required for school entry.

A wet swab of unknown origin placed deep in the nasal cavity and scraped against the blood brain barrier or the gathering of saliva and cheek cells containing DNA from inside the mouth IS invasive.

There is no data that provides evidence that healthy children are a danger to anyone, regardless of what the RT-PCR test result says. There is no evidence that testing reduces disease transmission. There is no evidence that asymptomatic spread happens.

Any measure that we take for public health must meet this criteria: *proven to benefit individual health and be free from side effects.* Contact tracing, covid testing and masking do not fit this criteria. Quite the opposite, it can be argued that they all cause harm.

I offer detailed and cited information below so that you may read for yourself some of the facts, data and philosophy that have helped me to formulate my opinion.

The loss of Liberty & Privacy.

Contact tracing violates privacy, and Liberty. It places, inappropriately, too much power in the hands of the unelected few. The implications of requiring tracing in order for people to live a normal life, such as to go to work or school, are far reaching and deeply alarming. If you do a little research on China and their contact tracing coupled with their social credit score you will begin to understand the slippery slope that rapidly leads to a dystopian, fascist technocracy, where an app powered by artificial intelligence (AI) tells you whether or not you may leave your house that day, based on "biometrics" or other social behaviors observed by AI. This technology already exists and is being used on humans today.

It is important to note that no test exists that can unequivocally determine whether or not someone is immune or contagious, and it is therefore a violation of natural rights to restrict the movement of free human beings based on a test.

The loss of human dignity and culture. Where are we heading?

In the past 8-9 months many human beings have been convinced of the necessity that we engage in inhumane behavior for our "safety". Without conclusive scientific evidence, we have collectively accepted that being near another healthy human is dangerous, that singers, trumpet players, and children are potential "super spreaders" of disease and that a face covering will "keep us and others safe".

Contrary to the success and survival of humans in all of history, and to the very nature of humanity as a social species, we have been convinced that we are "safer apart" and that is "social" to be distant. The concept of "safety" has superseded all of our previously revered cultural values. Visiting the elderly, comforting the sick, sitting with the dying, hugging our friends, group events that bring us joy and elevate our spirit are verboten. Why? Because we, in what was previously valued as the Land of Liberty, are no longer allowed to make our own decisions. Apparently, the majority are comfortable being dictated to. The state has taken on the role of parent and we must behave as compliant children, or else. We are informed, by the powers that shouldn't be, who tell us they are "experts", that this is the "new normal". A "new normal" that no human in their right mind (a mind free of fear panic) would agree to. I suggest that the world we are rapidly creating, through our acquiescence to the fear narrative, is not at all what we wish for our future. Almost all humans, except a small percentage of psychopaths, wish for a human culture that values Liberty and the freedom to pursue our passions and creativity; a culture that respects and reveres our planet; a culture that promotes thriving, loving, supportive, communities; a culture that invests in human creativity and celebrates diversity of people and thought; a culture that stewards the planet so as to maintain an environment that will eliminate man-made disease; and a culture where sovereignty over our own lives and the lives of our children is honoured as an inalienable truth.

We are at a crossroads. Will we choose to allow technocratic control over every aspect of our lives by an unseen elite or AI algorithm, or will we reclaim our place of dominion, governance and stewardship over all the earth?

We must create what we wish by placing ourselves in the driver's seat, looking ahead, and navigating toward what we wish. Reclaiming our place requires us to take personal responsibility for our decisions and how our decisions are shaping the culture around us. In my view, we have been sold a lie of disease and scarcity which is counter to all of creation which exemplifies health, abundance and balance. These are the big picture concepts; the existential beliefs that, if we as human beings must contemplate if we are to continue to exist and begin to thrive in health, balance and sovereignty.

Who are we? What do we value? What future will we create? Who and what do we serve? This is our opportunity to rise, contemplate the whole, and create that which we wish to see. News of a "viral pandemic" is distracting us and the fear is crippling us. It is time to set aside fear and open our minds to the totality of our existence and discover what we are called to do at this pivotal moment in human history.

The pandemic: a tool for control through fear.

We are informed that we are in the midst of a "viral pandemic". Those who have told us they are "experts"; who have slithered their way into positions of power, such as Anthony Fauci and Bill Gates have failed to provide the scientific proof that the measures they promote are actually warranted. They have failed to openly debate with other experts who disagree with the measures they mandate.

The "news" promotes fear, without substance. They fail to report actual data about death rates (.26%), facts about the limitations of the covid test (not a diagnostic tool & accuracy changes according to number of cycles), facts about the placebo studies indicating that masks do not change rates of illness (danish study), facts that tens of thousands of epidemiologists, social scientists, public health experts and medical doctors worldwide do not agree that shutting the economy down and destroying small businesses, masking the healthy population, RT-PCR testing the healthy, and unregulated contact tracing is the way forward. No, the "news" is not performing its stated purpose: investigative reporting; rather it is propagating a narrative unsupported by facts and omitting essential information and facts from its programming. Why would doctors and other experts be excluded from the "news" if they, based on data, proport that the measures we are taking are harmful and not supported by science? *Their* messages are measured, and not steeped in fear. Perhaps the "news" isn't aiming to investigate or report, but rather to steer the narrative toward fear to falsely necessitate draconian measures which will forever change society.

If that is their aim, inducing fear, they have certainly succeeded. The fear has become an effective tool to make previously rational human beings subservient and ready to upend their lives and values for the sake of "staying safe". People irrationally think that it will be over soon, or that an experimental vaccine that does not prevent spread of illness will automagically make everything go back to normal again. *Oh no, friends, if we do not put a stop to this ourselves, it will never end.* Life will become more restrictive, more divisive and more fearful.

During this pandemic, concepts that have never been in the consciousness are now accepted as truth. What was once known as a healthy person is now an "asymptomatic carrier", again an unscientific claim. Evidently, if you repeat a lie enough it becomes the "truth". As George Orwell described, we have accepted "double-speak" into our language, such as: "socially distant" and "together apart". I hope that the sources and details that I have included in this letter will encourage you to think critically about the decisions you have made this year. Up until now you have chosen to acquiesce to the measures mandated or recommended by the Washington State Governor and health departments. It is likely that you have chosen to blindly follow the recommendations without a second thought, believing that all relevant information regarding Covid-19 was at your fingertips, and that the "health authority" had reached a consensus based on scientific evidence and therefore deserved your obedience. I hope it is clear after reading this letter, that dissenting voices are numerous and have been suppressed. The media has been grossly negligent during this "crisis".

There are far reaching implications to the decisions being made by you right now. It is imperative that people making decisions that affect the lives of thousands of people begin to utilize their own critical thinking skills and their intuition to inform their actions. We are at a critical moment and we must think broadly and make decisions with measured wisdom so that we may preserve our Humanity and the Liberty that we have evidently taken for granted.

Covid-19 is not proven to be a viral, contagious disease:

Contrary to the popular narrative's unproven claims that we are in the midst of a "contagious viral pandemic", the cause of the illness "Covid-19" has never been proven to be an infectious viral disease. This is not a conspiracy theory, it is fact.

In July 2020, the FDA posted a CDC document entitled "CDC 2019-Novel Coronavirus (2019-nCoV), Real-Time RT-PCR diagnostic Panel. For Emergency Use Only. Instructions for Use." <u>https://www.fda.gov/media/134922/download</u> Buried in the text, on page 42, is the following statement: "... no quantified virus isolates of the 2019-nCoV are currently available." Yes, you read that correctly: 2019-nCoV, also called "SarsCOV-2" has never been isolated.

The genetic material, often called viral fragments or in modern virology, exosomes, that have been associated with Covid-19 have <u>never been proven to be</u> <u>able to cause disease</u>. Firemen may be present at a fire, but would we suggest, without evidence, that they caused the fire?

If contagion has not been proven, you may wish to ask what is the purpose of the "covid test"? The RT-PCR (Reverse Transcriptase Polymerase Chain Reaction) test, also called the "covid test" was not invented to be a diagnostic tool for "covid". The RT-PCR test shows the presence of fragments of genetic material that were associated with the symptoms of illness we call "Covid-19", however these fragments of genetic material can also be present in healthy people. The presence of these genetic fragments do not indicate illness, nor do they indicate that a "positive case" is infectious.

This is very important to understand because we have been led to believe that a "positive" test means that one is "contagious" and has disease even though neither assumption has been proven to be true.

We have also been told that the genetic material associated with Covid-19 is "novel". Yet, the "novel coronavirus SarsCOV-2" has a 100% sequence match to 86 human chromosome fragments, as is searchable in BLAST, an internationally available genetic database. I recognise that this information is difficult to digest and may cause a feeling of panic, rage, or an urgency to dismiss it outright. When our world view is shaken, it is truly upsetting. Opening our minds to these facts certainly does not induce warm and fuzzy feelings. It requires grit and resilience to take this information in. To be sure, there IS clear evidence of fraud and it is incumbent on you to look deeply and spend time with the information.

There is a powerful effort to censor and discredit those who share these facts. To be sure, we would like to believe that everything that is happening on the planet is legitimate and good, and that people "smarter than us" are taking good care of us. However, the evidence shows that the opposite is true. There are agenda playing out that have nothing to do with public health. The Inaccuracy of the Covid Test:

Furthermore, the "accuracy" of the RT-PCR test is dependent on how many amplification cycles it goes through. In light of these facts, we must be aware that "covid" testing healthy people could easily be abused in an effort to fictitiously count perfectly healthy people as "positive cases" in order to manufacture a "second wave", justifying soul crushing, deadly lock-downs, and more invasive, inhumane, technocratic "solutions".

I must pose these questions:

What is Covid-19?

Why is it that in the United States of America we are not allowed to have intelligent, disparate conversations about the most critical issue of our time?

Why is the public being kept from knowing that there are a variety of expert opinions about how we should respond to the disease named Covid-19?

The take-away: **know that there is not a consensus** and each one of us is called to utilize our own research and critical thinking skills as we make decisions for our own health and policies that affect our community.

Treatments & Risk to Children & healthy people under 65:

There are treatments that have been saving the lives of the small percentage of patients who get critically ill. One treatment that has been used worldwide, but has been widely censored and mischaracterized as "dangerous" in our country is a 5 day treatment of the 60+ year old malaria drug chloroquine/ hydroxychloroquine, with zinc and azithromycin.

Use a triple drug therapy: Hydroxychloroquine 200mg twice a day for 5 days, Zinc sulfate 220mg once a day for 5 days, Azithromycin 500mg once a day for 5 days. It has become clear when comparing outcomes of patients in countries who have used this treatment with countries who have not that it is indeed saving lives.
